The terms of office for the above positions commence October 1, 2019 and expire on September 30, 2022.

Members desiring to run for the above positions will so indicate by filing a properly executed nominating petition with the Local Secretary. **PLEASE READ AND FOLLOW ALL REQUIREMENTS.**

Nominating petitions must be in the Union office by 5:00 p.m. (or if sent by mail, postmarked not later than midnight), <u>WEDNESDAY, JULY 24, 2019</u>.

Nominating petitions must be signed by the applicant, properly witnessed and dated, and shall contain signatures from ten percent (10%) or ten (10) active members in good standing from the functional group, whichever is less.

Nominating petitions may be obtained from the Union office, Executive Board Members, or Stewards.

Candidates wishing to bring their qualifications before the membership may submit a statement consisting of written material only, regarding their ability, desire and willingness to serve. Such material must be capable of inclusion on a single 8 1/2" x 11" sheet of paper (one-sided only) using regular type with one inch minimum margins and must be delivered by the candidate or received by mail at the Union office not later than the close of business, <u>WEDNESDAY</u>, JULY 24, 2019.

ELIGIBILITY REQUIREMENTS:

All Executive Board members shall be members in good standing in Local 53 and must have been in good standing in NABET-CWA continuously for the two (2) years immediately prior to the date of nomination, and shall have achieved regular status in their respective bargaining units.

A daily hire member will be assigned to the unit where he or she has worked the most days during the previous eligibility period. When no days have been worked, he or she will be assigned under the unit in which he or she joined the Union.

Once elections are held, there will be no change in an elected position unless there is a death, resignation or recall. In that event, a Special Election may be held to fill the vacancy.

If an office is unfilled as a result of failure of anyone to file for that office, it will remain unfilled until the next regular annual election, when the office will be opened for election, regardless of which group it is in.

<u>PLEASE NOTE:</u> The elected candidate for Executive Board member may, on a rotating basis, automatically become a delegate to the annual CWA Convention.

Ballots will be issued on AUGUST 7, 2019, with a due date of AUGUST 21, 2019. Ballot counting will take place at the Union office on AUGUST 26, 2019.
